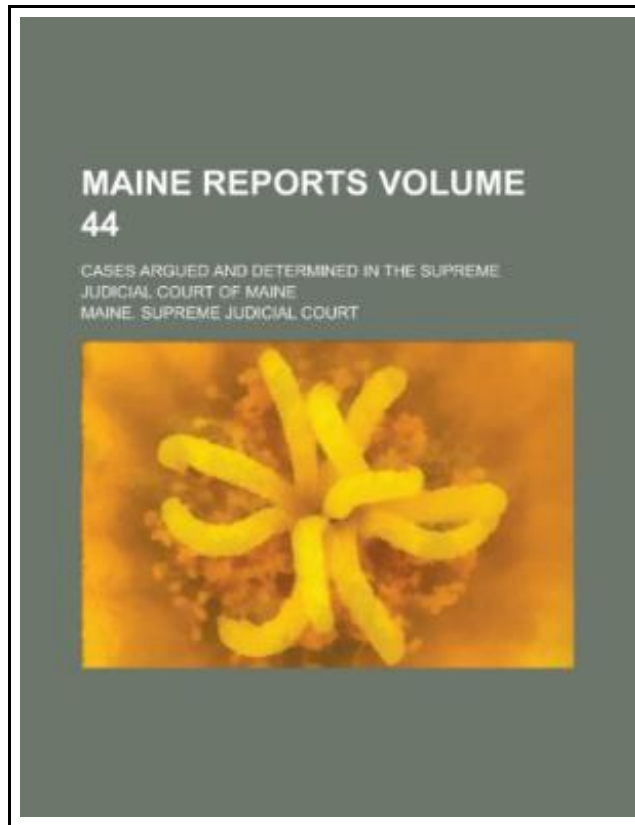

If damage be done by any domestic animal kept for use or convenience, the owner is not liable to an action on the ground of negligence, without proof that he knew that the animal was accustomed to do mischief before, if such animal is rightfully in the place where it does the mischief. If domestic animals are wrongfully in the place where they do any mischief, the owner is liable for it, though he had no notice that they had been accustomed to do such mischief before; and an allegation in the writ of such previous knowledge is unnecessary, and may be treated as surplusage.
